Smith Receives International Honor Society Scholarship

The Executive Council of Sigma Beta Delta International Honor Society for Business, Management and Administration recently named Tiffoney Smith as the recipient of its Scott Scholarship during the fall of 2021. The Council selected Smith from thousands of society members throughout the country.

Smith graduated Magna Cum Laude from Thomas University with a Bachelor of Science Degree in Management. She also received the award for Outstanding Undergraduate Student in the Division of Business.

Smith, who lives in Thomasville with her husband Recardo and their five children, took an indirect route to earning a college degree. The Sumter, South Carolina, native began by joining the Navy right after graduating from high school in 2010 at the age of 17.

For seven years Smith served in the Navy as an Aviation Ordnanceman, which required handling ammunition and missiles, loading and unloading them into aircraft. The work required a great deal of technical training in how to properly do the work. While in the Navy, Smith met and married her husband.

When she and her husband ended their military service, they decided to settle in Thomasville, her husband's hometown. That's when Smith realized she wanted to earn a college degree, but she also wanted a traditional college experience.

"We were in Thomasville, and I wanted to come and sit in the classroom," she said. "At least when I first started, I felt like because I had been out of school for so long, I needed to be able to get back in the right mindset. Because Thomas University is small, I got to know most of my instructors and peers."

Now Smith is working on a master's degree in Human Resources Management. She's a member of the TU chapter of Sigma Beta Delta and TU's chapter of the Society for Human Resource Management (SHRM).

Using Science and History to Preserve the Past

On June 2, 2022, recent TU graduate Baz Ouzts presented his project, which combined science and history at Pebble Hill Plantation through TU's Geospatial Analysis Planning and Preservation (GAPP) Center in an effort to record information about the graves in the Workers' Cemetery before the gravestones are lost to time and nature's elements. Ouzts used GIS technology and Pebble Hill's archives to map the location of each and identify the person buried there.

Ouzts' project built on an earlier project by TU GAPP students from 2013, but he added the historic element to tell the stories of the people buried in the cemetery and roles they played on the plantation. This information was meticulously documented during the 20th century by the last two owners – Kate Hanna Harvey, who owned Pebble Hill from 1901 until 1936, and then her daughter Elisabeth (Pansy) Ireland Poe, who owned it from 1936 until her death in 1978. The oldest grave in the cemetery is inscribed with a death date of 1898.

Because of the fragile nature of the graves, the cemetery remains closed to the public. However, more information is available at the website Ouzts created about the project: https://storymaps.arcgis.com/stories/7fce6a0b1a4045e8b89e93a5194cfd59.

TU Students, Professor Recreate Missing Museum Sculpture

In the fall of 2021, students of Richard Curtis, Associate Professor of Art, recreated the life-sized "Gold Star Mother" statue at Pope's Museum in recognition of the museum's listing in the National Registry of Historic Places.

Pope's Museum, located near Ochlocknee in Grady County, features about 200 of Forester's works of art. As one of the few women artists of her time, her work received much acclaim during the 20th century.

Forester created the original life-sized "Gold Star Mother" statue in the 1940s as part of a memorial to honor military service members who lost their lives in battle and to honor the families they left behind. Sometime between 2015 and 2017, the grieving mother statue disappeared from the memorial.

Curtis recruited three students to work with him in recreating the "Gold Star Mother" statue – Tiffeny McCardel, Jennifer Coleman and Georgia Smith.

"I thought it would be a unique learning experience for them," he said. "As a studio artist, I am always looking to include hands-on experiential learning into my lecture-based courses. This was a project to restore, or rather reinterpret, a monument that had been lost."

Plymale Receives 2022 TU President's Award

Aubree Plymale of Boston, Georgia, always enjoyed the outdoors and learning more about how to protect the environment and natural resources, so earning a degree in that field was always part of her plan. However, she did not realize that she would make history along the way.

On Saturday, May 7, 2022, she became the first student to graduate from Thomas University's new Bachelor of Science program in Natural Resource and Conservation Management and she did it with Summa Cum Laude honors. Plymale also became the first student to graduate through a partnership with Southern Regional Technical College in which students first earn an associate degree at SRTC in the Land, Forest, Wildlife Management program before moving on to TU.

In addition to those milestones, Plymale received Thomas University's 2022 President's Award, the highest honor presented to a student in recognition of his or her outstanding academic achievements and community contributions at TU.

When she graduated from Thomas County Central High School, Plymale enrolled in Southern Regional Technical College.

"In the fall of 2020, Thomas University started the natural resources and conservation management program, which allows students to graduate from Southern Regional and then transfer over and only take two years to get their bachelor's," she said. "That's why I chose this degree. It's right here in Thomasville so close to home."

At TU Plymale learned more about

the research aspect of NRCM. She presented a research project conducted with her classmates Hope McNair and Dara Moore at the Tri-Beta National Conference during the summer of 2022. In their project, the trio collaborated with Tall Timbers Research Station to examine the chemical, microbiological, and ecological factors of post-agricultural plots that are fire-dominated.

During her time at Thomas University, Plymale served as president of Tu's Mu Kappa Delta chapter of Tri-Beta Biological Honor Society. Under her leadership, the chapter hosted a guest speaker series, partnered with Keep Thomas County Beautiful, and hosted an Earth Day celebration at Cherokee Lake.

She also interned at Tall Timbers Research Station, where she created a conservation management plan for Lost Creek Forest.

"I would say my greatest reward would be the all the experience I've gained here at TU and all of the community partners that I've met through my time here,"

From Military to Civilian Life: Thomas University Announces New Transition Program Built Around Football

Thomas University officials have established the nation's first football program designed specifically to assist veterans in their transition from the military to civilian life. Tu's program will serve veterans and those currently serving in the Reserves and National Guard. In Tu's new program, these service members will be students on Tu's campus in Thomasville, earning undergraduate degrees and members of the newly formed Night Hawks football team.

"We see it as a win-win situation for everybody," said Stephen Ferguson, TU's Vice President for Military and Corporate Relations. "We know that service members learn how to operate as a team. We're going to use that training and apply it to football. This is more than just football. This is about preparing veterans for the next phase in their lives and using football as the vehicle to do that."

In addition to mentoring from coaches, including prior-service staff, TU will integrate its outstanding, nationally recognized



counseling program to provide both mental health and career counseling services.

"The best programs recognize that the transition from military service to civilian life includes multiple social, physical, psychological and economic challenges," said Dr. Pauline Patrick, Chair of the Social and Behavioral Sciences Division at TU. "It is necessary to focus on and provide services for the 'whole' person. TU's Veteran Transition Program will provide counseling, tutoring, structure, mentoring, education and other support services to assist these veterans."

TU administrators also introduced the first head coach of the new team, Orlando Mitjans, Jr. He brings more than two decades of coaching experience to the new program. Mitjans previously served in positions at The Citadel and West Point in addition to completing NFL internships with the Kansas City Chiefs, St. Louis Rams and New York Jets.

TU is part of the NAIA Division I Sun Conference. The Night Hawks will begin their first football season in the fall of 2023.

Thomas University Moves up to #4 on Top 10 List of Military Friendly Schools

For the fifth year in a row, Thomas University has been named to the Top 10 List of Military Friendly Schools® in the category of private colleges and universities not offering doctorate degrees. This year TU moved up from ranking eighth last year to ranking fourth for 2022-2023. The Top 10 ranking is in addition to achieving gold award status.

Institutions earning the Military Friendly® School designation were evaluated using both public data sources and responses from a proprietary survey. More than 1,800 schools participated in the 2022-2023 survey with 665 earning the gold, silver and bronze designations. The 2022-2023 Military Friendly® Schools list is

published in the May issue of G.I. Jobs magazine and can be found at www.militaryfriendly.com/schools.

In mentioning Thomas University on the list, Viqtory specifically referred to TU's customized training and certification preparation classes in a variety of areas, including contracting, cyber security and project management as well as its Center for Military Life, which supports military personnel and their families throughout military service from pre-enlistment to veteran status.

TU is a partner with the Community College of the Air Force offering seamless transfer of CCAF associate degrees to TU bachelor's degree programs. TU is an approved General Education Mobile (GEM) provider for Air Force personnel and an active participant in the voluntary education programs for all branches, providing access to quality education. The Veterans Services and Career Transition Center is available to all veterans and active duty personnel on campus and in the surrounding area.

Thomas University Holds Conference on Government Contracting for Small Businesses

Small business owners looking for an opportunity to begin government contracting learned how during a workshop at Thomas University on Friday, March 4, 2022. Presented by TU's Center for Military Life, "Government Contracting for Small Business" covered the basics of how to introduce a small business to the government contracting market, what small businesses need to consider in this market and strategies for successfully competing for government contracts.

"We wanted to share insights about the business of government contracting that small business owners may not fully understand," said Ron Poussard, a conference presenter who is a Distinguished Senior Fellow with the Armed Services Institute at Thomas University and President of Applied Federal Contract Associates. "It's a complex environment for any business and can be very challenging."

Other presenters included Michael Poussard, Associate Director for Federal Business Strategy at TU's Armed Services Institute; Roy Nyquist, Contract Training Coordinator of TU's Defense Acquisition Collaboration; and Kevin A. McGrail, Principal Evangelist for Dito and a member expert in the Marine Corps Cyber Auxiliary.

Session topics included "Introduction to a changing government marketplace," "Pathways and programs to successful entry," "A fresh look at federal small business programs" and "Cyber hygiene (Securing your network)."

TU students provide over 2 5 TOO community service hours annually

Georgia Council for the Arts awards ACTU an Arts Education Grant

The Georgia Council for the Arts (GCA), a division of the Georgia Department of Economic Development, announced in July 2021 that it awarded Arts for the Community at Thomas University (ACTU) an Arts Education Grant as part of its initial disbursement of grants for fiscal year 2022. A total of 218 organizations were awarded 266 grants that provide more than \$2 million in funding to arts organizations throughout the state. ACTU is one of 77 organizations in the state to receive an Arts Education Grant.

"As we emerge from this past year's quarantine, the arts sector is vital to restarting the economy by attracting tourists, assisting with classroom learning, and igniting events to bring communities back together," said GCA Executive Director Tina Lilly. "The 266

grants we have awarded will help cities and organizations leverage additional funds and bring people back to work while providing fun and educational opportunities for Georgians across the state."

Funds awarded by Georgia Council for the Arts include appropriations from the Georgia General Assembly and the National Endowment for the Arts.

"This grant will enable ACTU to increase and diversify our audiences for the Friday at Noon and Sundays at Four concert series," stated Dr. Karl Barton, ACTU series coordinator and Thomas University Professor of Music.

Georgia Council for the Arts uses Peer Review Panels to judge and review applications following standard practices set by the National Endowment for the Arts. Panelists are GCA Council members and fellow professionals who are experienced in the arts discipline or type of grant being reviewed, or are citizens with a record of arts activities, experience and knowledge. Grant recipients include theaters, dance companies, museums, cities, colleges, and multi-discipline arts entities.



NAACLS Reaffirms Accreditation of TU's Medical Laboratory Science

In the spring of 2022, the National Accrediting Agency for Clinical Laboratory Sciences (NAACLS) reaffirmed its continuing accreditation for Thomas University's Bachelor of Science Degree in Medical Laboratory Science for 10 years.

"Accreditation by NAACLS means that our program meets the established education standards in the clinical laboratory science discipline of Medical Laboratory Science set by the premier agency in the field," said Leslie A. Cooper, program director and clinical

coordinator. "The thorough and rigorous accreditation process and the fact that our program is one of only five accredited MLS programs in Georgia shows our continued commitment to deliver high quality education to both local students and beyond."

A Medical Laboratory Scientist is an integral part of the healthcare team and aids in the diagnosis of patients through scientific analysis of human samples to yield diagnosis and treatment. TU's MLS graduates are prepared to enter the field with a rich and diversified skill set enabling employment in a variety of laboratories, such as medical and hospital, forensic, pharmaceutical, drug trial, veterinary, physician offices, food and beverage, and other labrelated career fields.

TU's MLS program was the first program at TU to offer classes online. Now the program offers both online and on-campus courses. The 2022 class was the 19th to graduate. About 300 students have graduated from the program since 2002.

Cooper Receives Vulcan Teaching Award

During Thomas University's Undergraduate Commencement ceremony held Saturday, May 7, 2022, Leslie Cooper received the prestigious Vulcan Materials Company Teaching Excellence Award.

For the past 27 years, Vulcan Materials Company Southeast Division, in conjunction with the Georgia Independent College Association, has been honoring an outstanding professor with the Vulcan Teaching Excellence Award at select members of the Georgia Independent College Association. This award recognizes an outstanding faculty member who demonstrates strong academic skills in the classroom and provides leadership and support in the other areas of campus life

Cooper began her career at Thomas University in 2014 as the Medical Laboratory Science Program Advisor and Administrative Assistant to the Division of Science. In June 2018, she became the MLS Program Director and Clinical Coordinator.

During the past year, Cooper

She wrote a self-study report and hosted a virtual accreditation site visit. To prepare for the accreditation site visit, Cooper had to update most of the MLS curriculum to include program and course learning outcomes,

develop a curriculum map and program assessment method, as well as manage all of these updates for the TU curriculum committee, catalog and the Canvas course shells.

In her role, Cooper manages all Master shells for the MLS courses and coordinates all of the clinical placements for her students.



Ways of Giving

The information below is intended to provide general guidance. Please discuss as needed with your tax advisor the best way(s) for you to contribute to Thomas University.

CASH DONATIONS

Outright gifts of cash (which include donations made via check, credit card and payroll deduction) are often the simplest for you to make. The key is to make sure you keep record of the gift as required by the IRS. Thomas University will provide a gift receipt via mail, when a mailing address is provided.

STOCK DONATIONS

Publicly traded stock and other securities which you have held for more than one year may potentially have accumulated long-term capital gains and could make one of the best charitable gifts. Why? Because you may be able to deduct the current fair market value and avoid the capital gains tax that you may be required to pay if you were to sell the property outright.

However, you may not want to donate stock that is worth less than your basis. Instead, you could sell the stock outright so that you might be able to deduct the loss and then donate the cash proceeds to Thomas University.

GIFTS IN KIND

As demonstrated above, gifts of cash or stocks are relatively simple and may provide tax savings benefits, but many taxpayers make other types of donations, such as vehicles, collectibles, or services as in-kind contributions.

PLANNED GIFTS

Many other contribution vehicles are available, such as Wills, Charitable Remainder Trusts, Charitable Lead Trusts, Charitable Gift Annuities, etc.
